Re: Follow Up to Comments Received on the *Draft* Rules of Procedure and *Draft* Standard IS Guidelines and Requests for Additional Consultation

## **Dear Interested Parties:**

On December 6, 2018, pursuant to Article 12, Section 12.2.23 of the *Agreement between the Inuit* of the Nunavut Settlement Area and Her Majesty the Queen in right of Canada (Nunavut Agreement) and s. 38 of the Nunavut Planning and Project Assessment Act, S.C. 2013, c. 14, s. 2 (NuPPAA) the Nunavut Impact Review Board (NIRB) released *Draft* Rules of Procedure and *Draft* Standard Impact Statement (IS) Guidelines for comment and invited interested parties to provide comments on the draft documents by March 15, 2019.

By March 18, 2019, comments on the *Draft* Rules of Procedure and *Draft* Standard Impact Statement (IS) Guidelines were received by the NIRB from the following parties:

The *Draft* Rules of Procedure and the *Draft* Standard IS Guidelines and all comment submissions received to date can be accessed from the NIRB's website at www.nirb.ca/rules-of-procedure.

In reviewing the comment submissions received to date, several proponents have requested that the NIRB follow up by conducting directed engagement sessions to allow for more in-depth discussions about issues identified by reviewers and provided in summary form in their comments. Consequently, the NIRB staff will make themselves available for two follow up discussion opportunities about the *Draft* Rules of Procedure and *Draft* Standard Impact Statement Guidelines at the upcoming Nunavut Mining Symposium (April 1-4):

- On Tuesday, April 2, 2019 from 10:30 am -12:00 pm (EDT) at the NWT/NU Chamber of Mines Office in Iqaluit the NIRB will be available for further in-depth discussions with mining industry representatives; and
- On Wednesday, April 3, 2019 as part of the Regulatory Session of the Nunavut Mining Symposium from 8:30 am 10:00 am (EDT) at the Astro 2 Theatre, Frobisher Inn, the NIRB will be presenting an overview of comments and update of the next steps for the *Draft* Rules of Procedure and *Draft* Standard Impact Statement Guidelines.

As indicated in the NIRB's December 6, 2018 invitation to comment, the NIRB will entertain requests for directed engagement opportunities in support of this initiative on a case-by-case basis. In considering the comments received during the first comment period, the NIRB has decided to schedule a second 60-day opportunity for comments on revised drafts of the ROPs and IS Guidelines prior to their finalization. The Board will distribute notice broadly on the next comment period once the revised drafts have been prepared.
